Please note:

*Unused Flex dollars transfer from fall to spring semester. At the end of spring semester, unused Flex is non-refundable and cannot be transferred to the new academic year. Unused meals do not transfer from fall to spring and must be completely used at the end of each semester.

**All meal plan totals include sales tax (7%) and a bond and utility fee (\$161.15) that is assessed to all residence hall students on meal plans. This fee covers the cost of bond service for renovating Larson and Medary Commons, as well as the cost for utilities in these buildings.
